

# Morris County Orders for Easing Restrictions in Phase 2 of State Reopening Plan

## State and local recommendations for community members

- Stay at home, when able
- Should wear masks or cloth face coverings in all public places
- Practice good hand hygiene or use hand sanitizer frequently
- Avoid touching your face, eyes, mouth and nose
- Stay home when you are ill
- Vulnerable and high-risk populations limit time in public

## Travel

- Minimize or eliminate non-essential travel and follow travel quarantine guidelines for travel to high-risk areas
- Essential includes travel for urgent family, medical, and business-related needs
- Observe Kansas Department of Health and Environment's travel-related quarantine mandates at <https://www.coronavirus.kdheks.gov/175/Travel-Exposure-Related-Isolation-Quaran>; this order supersedes previous travel quarantine mandates ordered for Morris County

Mass Gatherings (# of individuals that are in one location and are unable to maintain 6ft or more distance between people (not including individuals who reside together))

- 15 or less per state guidance

## All Businesses

- Follow guidelines for cleaning <https://www.coronavirus.kdheks.gov/DocumentCenter/View/991/Cleaning-and-Disinfecting-Your-Business-PDF---4-29-2020>
- Should screen workers for fevers and any symptoms of COVID with a questionnaire at workplace entrance
- Employees should wear masks at all times unless prohibited by other safety equipment
- Workplaces should be 6 feet apart
- No more than 15 individuals in work groups
- Suggest staggering work shifts and keep work cohorts consistent when possible
- Common areas, such as breakrooms and lobbies closed if cannot maintain 6ft distance between tables or seating
- Telecommuting/Working from home should be maximized
- Businesses are encouraged to develop flexible sick leave policies to enable employees to stay home when ill or have been in contact with ill person
- Strongly consider special accommodations for workers who are members of a vulnerable population. For purposes of this guidance, these include elderly individuals and those with serious underlying health conditions, including high blood pressure, chronic lung disease, diabetes, obesity, asthma, and those whose immune system is compromised such as by chemotherapy for cancer and other conditions requiring such therapy.
- Business travel should be minimized

## Restaurants, Bars and Convenience Stores with self-serve food and beverage stations

- Should follow guidance from the National Restaurant Association <https://restaurant.org/Downloads/PDFs/business/COVID19-Reopen-Guidance.pdf>
- In restaurant dining is allowed and must adhere to mass gathering and social distancing guidelines. Seating must be arranged to allow for a minimum of 6 feet between customers/customer groups
- Self-serve food and beverages prohibited

- Buffets are prohibited
- Staff should wear masks
- Bars remain closed (unless previously serving carryout or curbside food)
- Follow guidelines for cleaning

### **Senior Centers**

- Centers should remain closed for communal meals
- Delivery or meal pick up should be available

### **Retail Businesses**

- Should provide shopping cart sanitation supplies
- Maintain social distancing of 6ft
- Employees should wear masks at all times
- Hand sanitizer should be readily available
- Marks should be applied to the floor in the area adjacent to each cash register to indicate where to wait for check out
- Plexiglass or glass barriers should be installed at checkout lanes
- Enhanced cleaning should be done throughout the workday

### **Long Term Care Facilities**

- Guidance per facility management direction
- Maintain distancing as much as possible
- Recommendations to adjust the layout of common areas including dining facilities to maintain 6 feet between residents
- Closed to public
- No visitors to facility should be allowed
- Staff must be monitored for symptoms of COVID 19 prior to work and masks should be worn

### **Hair Salons and Barber Shops**

- Follow guidance per Kansas State Board of Cosmetology

- Both service provider and customer should wear a mask/cloth face covering

- Services provided by appointment only per state
- Should keep record of all customers
- Appointments spaced so that there is adequate time to clean thoroughly between customers
- One customer is allowed per service provider in the business at any given time
- Should screen customers for symptoms of COVID 19

### **Religious Services**

- Religious services should adhere to social distancing guidelines and maintain social distancing of 6 feet for more between individuals and or family groups (individuals living in same household)

- Parishioners, staff and volunteers are encouraged to wear masks
- Church is responsible for ensuring that guidelines are followed
- Enhanced cleaning between services is strongly

- Churches should keep an attendance log for each service or activity and should include names of all people in the building (if needed for contact tracing)
- Churches are strongly encouraged to use telecommunications tools whenever possible to conduct services

### **Recreation Activities/Organized sports**

- Must follow mass gathering and social distancing guidelines
- Must follow Kansas Recreation and Park Association guidelines

### **Parks, Public Spaces and Playground Equipment (including schools)**

- Parks and public spaces are open
- Use of playground equipment and picnic tables allowed (user is responsible for sanitizing)
- Maintain social distancing of 6ft or more
- Informational signage should be posted

### **Farmer's Market**

- Vendors should be spaced 10 feet apart
- Masks should be worn
- Social distancing guidelines must be observed
- Limit 1 customer (or family) per vendor at a time

### **Public Swimming Pools**

- Not allowed per state

### **Gyms and Fitness Centers**

- The business is responsible for ensuring that guidelines are followed
- The business should keep a record of all customers using facility per day
- Must adhere to social distancing guidelines, allowing people to remain 6 feet apart at all times
- Equipment must be cleaned thoroughly between uses with a cleaner approved by EPA to kill COVID 19
- Activities with shared equipment should be avoided
- Customers should be screened for COVID 19 prior to entry
- Pool closed per state guidelines
- In-person group classes may occur with 15 or less people
- Locker rooms must be closed except as necessary to use restroom facilities per state guidelines

### **Community Events**

- Must adhere to mass gathering and social distancing guidelines
- The entity organizing the event is responsible for ensuring that all guidelines are being followed
- Hand sanitizer or handwashing stations should be readily available throughout the premises for the duration of the event
- Community Centers must follow mass gathering and social distancing guidelines per state

## **Morris County Orders for Easing Restrictions in Phase 2 of State Reopening Plan**

- Fairs, festivals, and parades per state guidelines
- Outdoor and indoor large entertainment venues with capacity of 2,000 or more prohibited
- In-person commencement or graduation ceremonies may occur with no more than 15 individuals in a room, gymnasium, or facility at one time as long as 6-foot social distancing is maintained. Outdoor drive-through graduation ceremonies during which no more than 15 individuals are in the same area outside of their vehicles at a time (i.e. school administration, graduate, family members, etc.) are allowed per state

### Education

- Per KSDE, school district and local public health
- K-12 Facilities remain subject to EO 20-07 regarding school closures
- Fewer than 15 students, instructors, or staff be present for normal operations

### Libraries

- May be open
- Social distancing must be maintained
- Frequent cleaning strongly encouraged

### Summer Camps

- Not allowed per state guidelines

### Medical Offices

- Per hospital/clinic

### Council Grove Federal Lake

- Follow guidelines from Corp of Engineers
- Boat ramps open
- Restrooms and showers are closed until June 1, 2020; cleaning schedules will be posted when opened
- Camp sites are closed until June 1, 2020
- Group shelter houses closed

Businesses, Organizations, or facilities may have more strict regulations than what are given by state and local authorities, but may not be less restrictive.

The following plan will be effective May 22<sup>th</sup>, 2020 and will remain in place during the duration of the state's phase 2 plan, unless ordered by the Morris County Health Officer.
